THE PUBLIC'S NEED FOR INDEPENDENT ANALYSES OF FAIR DRUG PRICES CAUSED THE ORGANIZATION TO GROW AT A FAST PACE THAN IT WAS ABLE TO CULTIVATE NEW DONORS TO SUPPORT THE WORK, MEANING IT RELIED ON A FEW SELECT DONORS TO SUPPORT THE SCALING OF THE ORGANIZATION. THE ORGANIZATION HAS BEEN BUILDING ITS INFRASTRUCTURE AROUND THE PUBLIC NEED, NOT AROUND DONORS, WHICH HAS MEANT THE ORGANIZATION FAILED THE 33 1/3% TEST THIS YEAR. LATE IN 2018, THE ORGANIZATION HIRED A FUNDRAISING PROFESSIONAL TO BE SINGULARLY FOCUSED ON INCREASING THE NUMBER OF DONORS FROM THE GENERAL PUBLIC. IN 2019, ICER ADDED A "DONATE" BUTTON TO ITS WEBSITE, AND ICER HAS HAD A 126% INCREASE IN THE NUMBER OF INDIVIDUAL DONORS IN 2019.
